AUTOMATIC / BUDGET PLAN HEATING OIL DELIVERY AGREEMENT

SECTION 6

Customer will pay for heating oil delivered to the above address, in accordance with the terms and conditions mentioned below in this agreement.

Terms of Agreement:

1. **Automatic Delivery contract:** deliveries will begin in September and will continue until such customer notifies Corporal Heating to terminate the contract by email. Payments are due within 15 days of delivery.
2. **Automatic Delivery / Budget Plan:** Deliveries begin in September and will end on April 30 of the following year. Your first payment is due in August and every 30th of the month thru June of the following year.
3. **Will Call Budget Plan:** Deliveries begin in September and will end on April 30 of the following year. Your first payment is due in August and every 30th of the month thru June of the following year. Customers are responsible for checking the fuel level.
4. Automatic, Budget Plan and will call accounts must provide Corporal Heating with a valid credit card.
5. Deliveries after April 30 are not part of any Budget plan contract and must be paid within 15 days of delivery.
6. Customer authorizes the use of credit card on file if payment not received after 30 days.
7. All Budget and will Call payments are due on the 30th of every month. Customer / property owner agrees to pay for any collection and attorney fees if necessary.
8. A fee of \$25.00 will apply to any returned checks
9. Future Automatic deliveries will be put on hold for past due payments over 30 days.
10. Corporal Heating will not be responsible for any system or property damage in the event customer runs out of fuel due to non-payment under the terms of this agreement.
11. Vent alarm (whistle) must be in good working order.
